#### Trustee Hoving

It is time to renew our service agreement with Deb Fisher who maintains our website. Her management fee for the year is \$480.00. There is an additional fee from a company named Starlogic that is also required to host the website and which has been previously billed to Deb ever since the time of our original agreement. She is requesting that these charges be billed

directly to Lilley Township in the future by providing our credit card number for direct billing as is done by the other Townships she manages. I am requesting approval for these fees not to exceed \$1500.00 and for her to furnish the Township credit card for any future service provider fees. Our goal is to convert our website to a free .gov website domain which hopefully will be completed before August 2025. In addition, I request that her fee be raised to \$500.00 per year as her workload services are increasing. We can anticipate that there will be an additional setup fee for her work in converting us to a free .gov domain. The credit card would only be used for any future charges, which we will be made aware of by Deb.

Much discussion followed regarding the credit card issue, Clerk Nelson will get in touch with Deb and check on the charges.
